NAFCOC NEW MEMBERSHIP POLICY

MEMBERSHIP:

The members of NAFCOC are the subscribed Affiliated Sectoral Constituencies, Organised Sectoral based Provincial Structures and any other Organised Business Formations, Bodies as well as Associations admitted in accordance with the NAFCOC constitution.

1. The New NAFCOC Membership form is divided into three categories viz;

Affiliated Sectoral / Individual members/and companies
Corporate members /companies
Honorary members

(The membership fee FOR ALL CATEGORIES is renewable each year).

1.1 Individual / Affiliated Sectoral members

These members shall be ADMITTED to membership and be entered in the Province Sectoral members' register data of which will be transferred to the National Office Membership Register on a quarterly basis. **THE MEMBERSHIP OF NAFCOC IS ONGOING – i.e there is no limitation on membership.** Every body is expected to renew membership on an annual basis. NAFCOC National Office Membership Department will send “**REMINDER/ S**” two months prior to the various membership expiry dates. **Please note:** there is a grace period of sixty (60) days after the expiry period after which period membership will then be terminated without any further notice. **The fee is R500,00 per year. For ordinary members in each sector**

1.2 Corporate Membership is also divided into four (4) categories viz:

-	Platinum	-	R100 000 p/a
-	Gold	-	R 50 000 p/a
-	Silver	-	R 15 000 p/a
-	Small Enterprises	-	R 3 500 p/a

1.2.1 Platinum Corporate Members:

This category is State –owned parastatal as well as Big Private companies for example, Transnet, TELKOM , ESKOM and the private companies like the South African Breweries, Insurance companies like Old Mutual, Sanlam ,Metropolitan, ASSUPOL Life etc. They have 100 % or more of Publicity through their Internal policies / procedures and are still open for participating in NAFCOC Activities etc. NAFCOC to establish long-term partnerships – this category partakes in ALL NAFCOC activities, serve as ADVISORS in their various specific areas and they should be willing to do business with Nafcoc members. The turn-over should be from R 100m-R 500m and above. **The fee is R100,000.00 per year.**

1.2.2 Gold Corporate Members:

This category has got Publicity can also partake in the NAFCOC Policy –making; can also be part of NAFCOC Delegations / Representations (both Local & Abroad). The turn-over should be from R35 m million and above. **The fee is R50,000.00 per year.**

1.2.3 Silver Corporate Members:

This category does not have much publicity but can also partake in NAFCOC Activities i.e Summits / Conferences etc can also interact with NAFCOC various structures. Their turn-over is from R20 million and above per year. **The fee is R15,000.00 per year.**

Small Enterprises R 3 500:

This category comprise of small business that want to make special contribution to NAFCOC.

1.2.4 Honorary members

They still fill in the membership forms, but the Council has to confer their Honorary membership, after which Membership Department shall advise them accordingly. This category is free. The membership department SHALL submit the list of Honorary members applications through to the Federal Council (**via the Deputy President**). The outcome of their applications will be communicated to the Honorary members.

Members should note that there is a probationary period of twelve months before they can be voted to any NAFCOC Office. Membership benefits are not transferrable to non-NAFCOC Affiliated members.

2. BENEFITS OF BECOMING A NAFCOC MEMBER:

 - ✚ Collective sectoral decision – making (through Conferences / Summits / Strategic Sessions etc.
 - ✚ Partnerships established with Government and State Owned Enterprises e. g. Department of Trade & Industry and its Business Units and State Owned Enterprises like Transnet; ESKOM, TELKOM etc.
 - ✚ Representation in all the Government structures and / or Departments
 - ✚ Representation / Participation in NEDLAC
 - ✚ Representation on the Boards of Government Paratstatals
 - ✚ Involvementy in the Local, District, Regional , Provincial municipalities Contracts and Tenders
 - ✚ Participate in nafcoc shared business at all levels and sectors
